

GUIDE TO ORIGINALITY/COPYRIGHT SPECIFICATIONS FOR PAPERS PUBLISHED BY THE INSTITUTION OF ENGINEERING AND TECHNOLOGY

The procedures and requirements for the publication of papers submitted to journals published by the Institution of Engineering and Technology are described below. The Institution of Engineering and Technology must be in receipt of a completed and signed Statement of Originality form (page 4) as well as the Publication Agreement and Assignment of Copyright form (page 5). Without either of these, the Institution of Engineering and Technology is unable to proceed with publication. Please also see page 3 for details of our Pre- and Postprint Policy.

1. Originality

It is the policy of the Institution to publish original material. So that the submitted paper may be considered for publication and, if appropriate, refereed, all authors (also see 2.7 below) are asked to sign the Statement of Originality on page 4 of this form. This Statement applies to the paper as submitted and to the paper as it may be revised by the author(s) prior to publication.

2. Copyright

2.1 It is a requirement of Bylaw 86 of the Institution of Engineering and Technology that every paper presented to the Institution of Engineering and Technology and accepted for publication and the copyright therein shall be the property of the Institution of Engineering and Technology.

2.2 The copyright of the paper must be assigned to the Institution of Engineering and Technology by means of the Publication Agreement and Assignment of Copyright (page 5).

2.3 Where the author(s) is/are employed by the Crown, or if for any other reason the Crown has any rights in the paper, then having regard to the provision of Section 163 of the Copyright, Designs and Patents Act 1988, the author(s) must obtain permission to publish from the Controller of HM Stationery Office. Other consents may also be required.

2.4 In the U.S.A. copyright protection is not available for 'works of the U.S. Government' i.e. a work prepared by an officer or employee of the U.S. Government as part of that person's official duties, or on behalf of the U.S. Government. Such work can be freely copied in the U.S.A., and copyright in it cannot be claimed by a publisher. Similar provisions may apply to work done by Government employees in other countries.

2.5 If the copyright of the work is owned by the author(s), the Agreement should be signed and dated by the author(s) at space A. (The author(s) assert(s) to the Institution of Engineering and Technology that he/she/they has/have the moral right to be identified as the author(s) of the work in accordance with the Copyright, Designs and Patents Act 1988).

2.6 If the copyright of the work is owned by the organisation which employs the author(s) or which has commissioned the work on which the paper is based, an authorised representative of that organisation should sign and date the Agreement at space B. (Note that when a work is made by an employee in the course of employment, the employer is the owner of any copyright in the work, but subject to any contractual variation of this position, agreed between the employer organisation and the employee author(s).)

2.7 If it is not possible or impracticable for all authors to sign the 'Statement of Originality' and the 'Publication Agreement and Assignment of Copyright', the corresponding author may sign on their behalf. In doing so, the signatory confirms that all authors have given their permission for the signatory to act on their behalf.

2.8 The organisation in assigning the copyright in the paper gives no warranty expressed or implied that the paper is free from defamatory matter, nor that the paper does not infringe the rights of any third party.

2.9 The organisation warrants that it:

- a) has advised the author(s) of his/her/their responsibilities to avoid defamation or infringement of third party rights, and
- b) will notify the Institution of Engineering and Technology of any adverse claim that comes to its knowledge prior to publication.

2.10 Nothing in the Agreement shall in any way affect any agreement which the organisation may have with any of its employees or others performing work for or on its behalf.

2.11 The author(s) and/or the organisations for whom the work was performed shall be entitled:

- a) to retain all proprietary rights other than the copyright such as patent rights;
- b) to reproduce figures and extracts from the paper with proper acknowledgement to the Institution of Engineering and Technology;
- c) to reuse all or portions of the paper in other works with proper acknowledgement to the Institution of Engineering and Technology;
- d) without payment to make and have made copies of the published paper for his/her/their/its own purposes but not for sale, provided that no reference is made to the Institution of Engineering and Technology in any manner which implies endorsement by the Institution of Engineering and Technology of any product the organisation manufactures or in which it deals.

2.12 If the Institution of Engineering and Technology declines to publish the paper, the copyright in the paper will remain with the original copyright owner(s). If the paper is accepted for publication but is not published within a reasonable time after acceptance, the copyright owner(s) will have the right to require the Institution of Engineering and Technology to reassign the copyright in the paper to the original owners.

PRE- AND POSTPRINT POLICY

The author(s) and/or the organisations for whom the work was performed shall be entitled:

To post preprints of their work on the author's web site, the author's employer's server and the server of any other body contributing financially to the research reported, as long as

a. access to such servers is not for commercial use and does not depend on payment of access, subscription, or membership fees and

b. the following wording clearly appears on the front page of the preprint:

"This paper is a preprint of a paper submitted to [journal] and is subject to IET copyright [URL]. If accepted, the copy of record will be available at [IET Digital Library URL]"

On acceptance, this may be changed to:

"This paper is a preprint of a paper accepted by [journal] and is subject to IET copyright [URL]. When the final version is published, the copy of record will be available at [IET Digital Library URL]"

If the paper is rejected, then all mention of the journal should be removed.

c. The preprint should be removed if a subsequent postprint is posted.

To post postprints of their work (reviewed, revised and accepted for publication by the Institution of Engineering and Technology) on the author's web site and the author's employer's server and the server of any other body contributing financially to the research reported, as long as

a. access to such servers is not for commercial use and does not depend on payment of access, subscription, or membership fees

b. the following wording clearly appears on the front page of the postprint:

"This paper is a postprint of a paper submitted to and accepted for publication in [journal] and is subject to IET copyright [URL]. The copy of record is available at [IET Digital Library URL]"

c. The postprint must be the author's version and not the Institution of Engineering and Technology's version/PDF.

d. The postprint must not be posted prior to publication of the paper by the Institution of Engineering and Technology and when posted any preprint version should be removed.

Any questions should be addressed to the publisher.
